【Seminar Overview】

Corporate commitment to respecting human rights is essential for sustainable growth. Globally, the expansion of environmental, social, and governance (“ESG”) investing and demands for human rights due diligence across entire supply chains are intensifying, making this commitment increasingly vital for enhancing corporate value and mitigating reputational risk.

The Japanese government has formulated the "National Action Plan on Business and Human Rights" and the "Guidelines on Respecting Human Rights in Responsible Supply Chains," supporting corporate initiatives.

This seminar will cover international trends and the Japanese government's initiatives, explain respect practices of human rights that companies should implement now, and introduce case studies from leading companies, in particular for Japanese companies expanding into the Philippines or considering business involving the Philippines.
